# Macro Economics and Monetary Economics

In the context of fundamental determinants of exchange rates, Ashima Goyal (Evolution of India's Exchange Rate Regime," Chapter 14 in Sameer Kochar (ed.) Growth and Finance: Essays in Honour of C. Rangarajan, 2011) analyzes the changing INR trends over the reform period. In the early reform years the chief concern was to limit appreciation from inflows, and from higher domestic inflation, given the trade deficit. Hence short-term nominal depreciation maintained a long-term real fix. She addresses how the exchange rate could contribute to three possible policy objectives-maintaining a real competitive exchange rate, neutralizing inflationary oil shocks, deepening foreign exchange markets and encouraging hedging.

Ashima Goyal examines the 'History of Monetary Policy in India since Independence' (Report for 2010-11 first Professor P.B. Brahmananda Memorial Research Grant Award, 2011) in the context of interplay between domestic structure external factors. The many changes and recorded, and dynamism displayed, by the economy, its institutions and policy, counter the argument that democracies are doomed to stagnation. The future will see these years as transformative for India and its institutions. In an interesting study Ashima Goyal ('Inflation Pressures in South Asia', for Economic and Social Survey of Asia and the Pacific. UN-ESCAP Project Report 2011. UNESCAP working paper at: http:// www.unescap.org/pdd/publications/workingpaper/ wp 11 14.pdf) brings out the similarities yet differences across South Asian countries. and argues that their differential response to recent food and oil price shocks, gives a useful opportunity to better understand the structure of inflation in these economies. The analysis brings out the importance of food prices for the inflationary process. Ashima Goyal ("Inflows and Policy: Middling Through", *India Development Report 2011*, Chapter 11, D.M. Nachane (ed.), New Delhi: IGIDR and Oxford University Press, Forthcoming) has made a survey of India's policy choices over the reform period with respect to liberalization of the capital account, their underlying rationale and politics, demonstrated the kinds of capital inflows that resulted; their special characteristics, and examined the impact of and handling of the East Asian and the Global Financial Crisis.

By testing the causal relation between CPI and WPI inflation using a battery of time series techniques on the indices and their components, Ashima Goyal and Shruti Tripathi (Extracting Information on Inflation from Consumer and Wholesale Prices and the NKE Aggregate Supply Curve." WP-2010-012. http://www.igidr.ac.in/pdf/ publication/WP-2010-012.pdf) find that supply shocks play an important role. The insignificance of the demand variable in short-run adjustment indicates an elastic aggregate supply. The exchange rate affects consumer prices. There is no evidence of a structural break in the time series on inflation. Convergence is slow, and this together with differential shocks on the two series may explain their recent persistent divergence.

In the paper "Monetary Policy in a low Inflation Environment: Is there evidence for Opportunistic Behaviour?," Naveen Srinivasan (with M. Ramachandran and Sudhanshu Kumar, *Journal of Quantitative Economics*, New Series Vol. 8 (2), July 2010, pp. 4-19) argues that the Opportunistic Approach to disinflation is an influential model of optimal monetary policy. This strategy for disinflation suggests that in a low inflation environment policymakers' would give higher weight to inflation stabilization when inflation is strengthening, but higher weight to stabilizing output when the economy is



already producing lower inflation via favorable supply shocks. In another paper titled "Ruling out unstable equilibria in New Keynesian models," Naveen Srinivasan and Patrick Minford (Forthcoming in Economics Letters, 2011) propose that The New Keynesian (NK) Taylor-rule model of inflation should be formulated with a money demand function and also embody a terminal condition on inflation, implemented by switching to a money supply policy explicitly designed to stop bubble paths at some point should they occur.

In the study "The Future of Financial Liberalization in South Asia," Ashima Goyal (WP-2010-022. November 2010, http://www.igidr.ac.in/pdf/publication/WP-2010-022.pdf) distinguishes between liberalization of domestic financial markets and capital account convertibility and argues that deepening domestic markets and better domestic and international regulation is a necessary prerequisite for full convertibility. The direction of future liberalization should be such as to meet Indian needs of financial inclusion, infrastructure finance, and domestic market deepening.

# **Development Economics**

Rising food prices would significantly undermine the food security and livelihood of the most vulnerable by eroding their limited purchasing power. In the paper titled "Rising Food Crisis and Financial Crisis in India: Impact on Women and Children and Ways of Tackling the Problem" (IGIDR Working Paper, WP 2011-003), S. Mahendra Dev examines the impact of rising food prices and financial crisis on the impact of women and children in India. The paper identifies the pathways for dealing with the effects of the crisis and suggests desirable macro and sectoral policies and measures which would mitigate the negative effects and effectively protect households during the crisis with special focus on the issues of nutrition, health, education and enhancement of child protection.

Evaluating the impact of NREGS scheme, the study by S. Mahendra Dev on "NREGS and Child Well Being" (Working Paper, IGIDR, WP-2011-004) addresses the host of issues such as 1) the pathways in which NREGS affect households, especially children 2) changes in child labor pattern 3) changes in the expenditure pattern of families 4) impact on women's well-being and empowerment and 5) availabilities of child care facilities at worksites.

Examining the rising inequalities in India in recent times, Sripad Motiram (with Arjun Jayadev and Vamsi Vakulabharanam), "Patterns of Wealth Disparities in India: 1991-2002," in Sanjay Ruparelia, Sanjay Reddy, John Harriss and Stuart Corbridge (eds.), *Understanding India's New Political Economy: A Great Transformation?* London: Routledge, 2011, documents the rise and consolidation of an urban elite that can be argued to roughly correspond to the new Indian middle class or white-collar workers. The study also documents the wealth and power of the rural elite, which has its roots in land in rural areas, but is also involved in non-agricultural activities, and has links to small towns and cities.

Analysis of household resource allocation and labor market by Ashima Goyal, ("Developing Women: Why Technology Can Help," Journal of Information Technology for Development, Vol. 17(2) pp. 112-132. April, 2011) shows that a small difference in the technology of production of the household good magnifies relative costs of external work for women. But devoting more time to the household lowers their human capital and perceptions of their abilities—they get stuck in self-reinforcing low-productivity traps. Equilibria satisfy static efficiency but are dynamically inefficient. Information technologies (IT) lower matching costs and make flexi-time-space, high paying work feasible. But special policies are required to change entrenched perceptions.

S. Chandrasekhar ("Factors Affecting Age at Marriage and Age at First Birth in India" Journal



of Quantitative Economics) attempts to identify the determinants of age at marriage and age at first birth and establishes the negative relationship between educational attainment and prevalence of underage marriage using Census 2001 data.

Srijit Mishra and Hippu Salk Kristle Nathan ('Progress in Human Development: Are we On the Right Path? *International Journal of Economic Policy in Emerging Economies*, 3(3): 199-221, 2010) measure progress, deviation and fluctuation for 127 countries in the period 1990-2004 by using the displaced ideal method that calculates human development index as the inverse of the Euclidian distance from the ideal. The paper, published prior to the *Human Development Report 2010*, has robust results as they match with that echoed in the report.

Chandan Kumar and Srijit Mishra "Banking Outreach and Household level Access: Analyzing Financial Inclusion in India" (presented at the '13th Annual Conference on Money and Finance in the Indian Economy,' Indira Gandhi Institute of Development Research, Mumbai, February 25-26, 2011) attempt to measure and understand financial inclusion by looking at supply of (banking outreach indicators such as number of deposit and credit accounts, number of bank branches, average deposit and credit amount per account and credit utilized) and demand for (indicators of household level access such as the proportion of households having saving, credit and insurance facilities) financial services. They find that the presence of the informal sector in providing financial services is significant, especially in rural areas. Their suggestion is: to widen the ambit of policy initiatives under financial inclusion, which will reduce the dependency on informal source of financial services, particularly credit and to provide greater focus on vulnerable states / regions in providing access to financial services.

Institutional capacity for information generation and its effective use is a crucial factor in policy formulation, monitoring and its evaluation. This is an issue which would matter even for a small country like Brunei which having virtually eradicated deprivation in its multiple dimensions, seeks to sustain this achievement with a threedecade vision for knowledge based economy. In his report "Statistical System in Brunei Darussalam: An Evaluation" (Department of Economic Planning and Development, Prime Minister's Office, Bandar Seri Begawan ), M.H. Suryanarayana provides a description of the available information base, its relevance in tracking the MDG progress and evaluation and for policy choice and design.

Given the contemporary global emphasis on mid-term evaluation of the progress towards the Millennium Development Goals (MDGs), the study by M.H. Suryanarayana and S. Chandrasekhar, ("Deprivation: Profiles and Policy Imperatives," Chapter for Economic Survey 2010-2011 of Government of Karnataka, 2011) reviews issues related to deprivation and inequality in consumption and education in rural and urban Karnataka. It reviews Karnataka's performance in reducing consumption deprivation in the rural and urban sectors and evaluates the findings in an integrated perspective with reference to education, skills and employability. The average age at time of enrolment is higher at 5.8 years in Inland Northern region compared to five years in Inland Eastern region. In terms of policies and interventions, data from the NSSO 64th Round (July 2007-June 2008) Survey on Participation and Expenditure in Education suggests that the government is indeed focusing on the Inland Northern region.

In the context of Eleventh Five Year Plan perspective on distributional dimension of changes in food security, M.H. Suryanarayana ("Food Security, Poverty and Health Status in India: An Outcome Evaluation Perspective,"



Somayajulu, U.V., C.P. Prakasam, in N. Audinarayana and K.E.Vaidyanathan Health, Poverty and Human Development: Perspectives and Issues, Global Research Publications, New Delhi, pp. 121-151, 2011) has examined the veracity of the Eleventh Five Year Plan assessment of and recommendation for food security in India. The study brings out that real consumption expenditure of all the decile groups, the bottom three decile groups in particular, increased since the mid-70s. With changes in infrastructure and technology, average energy requirements seem to have declined calling for reduced calorie intake. This could be one major reason for the observed trend decline in average calorie intake of the richer decile groups in rural and urban India. There is a need for revising downward the calorie norms consistent with the converging pattern of changes in calorie intake in across decile groups in rural and urban India. The case for such an approach is validated by the survey findings, which show that the percentage number of rural and urban households reporting adequate food consumption throughout the year has increased since 1983 and has reached almost 98 per cent. This would raise the question regarding an appropriate norm and strategy for food security.

In the light of growing concern with inequalities in India and the focus of the Government of India on inclusive growth, M.H. Suryanarayana ("Inequality-adjusted Human Development Index: States in India," paper prepared for the Planning Commission, jointly with Ankush Agrawal and Seeta Prabhu, 2011) adopts the methodology proposed in the HDR 2010 to compute a HDI and the Inequality-adjusted HDI for the states in India. To facilitate cross-country comparison, the indices are normalized with reference to the goalposts mentioned in the HDR 2010. The findings demonstrate the need for a disaggregated analysis of the various dimensions contributing to the differences in human development attainments across the India states.

Rupayan Pal ("The Relative Impacts of Banking, Infrastructure and Labour on Industrial Growth: Evidence from Indian States," Macroeconomics and Finance in Emerging Market Economies, Vol. 4, No. 1, pp. 101-124, Routledge, 2011) analyses the impacts of outreach of banking services, infrastructure penetration, and labor market rigidity on growth of manufacturing industries across 14 major states in India in the post-liberalization period from 1991-92 to 2002-03. It documents that outreach of banking sector as well as infrastructure penetration has significant positive impact on growth of industries. Interestingly, the counteracting effect of labor market rigidity does not appear to be significant, if the effects of infrastructure and banking services are controlled for. This article also assesses the relative magnitudes of the impacts of these three institutional factors on industrial growth.

# **Agriculture and Rural Development**

Srijit Mishra ("Economic Reforms, Small Farmer Economy and Agrarian Crisis" by D. Narasinha Reddy and Srijit Mishra, 2010 in R. S. Deshpande and Saroj Arora (eds) Agrarian Crisis and Farmers' Suicides, Sage, 2010) pays attention to the 'agrarian crisis' with particular reference to small-marginal farmers and the associated resource and institutional constraints that have been on the rise since the initiation of economic reforms. The study discusses the growing marginalization and the constraints on small farms, the reforms in agriculture and their impact in a political economy framework, the nature and dimensions of farmers' indebtedness problem, the deterioration of the livelihood of small-marginal farmers, the nature and dimensions of farmers' suicides and ends with a proposition that institutions in the small-marginal farmer collectives give some hope.

The twin dimensions of the crisis – the agricultural and the agrarian has been studied



by Srijit Mishra (with D. Narasimha Reddy) in 'Persistence of Crisis in Indian Agriculture: Need for Technological and Institutional Alternatives' (in Dilip M. Nachane (ed) India Development Report 2011, Oxford University Press). There is an increasing incidence of calorie poor among cultivators and agricultural laborers - the hands that produce food do not get adequate amounts to consume. There is a need to do away with input-intensive cultivation in favour of costreducing knowledge centric technology that builds on local resources and further strengthens the existing social capital. The latter is possible through structures that empower the farmers at the grassroots, and organize them into federations so that they can aggregate different things at different levels. These sentiments are further echoed in Srijit Mishra's 'Agrarian Crisis and Farmers' Suicides in India,' (paper presented at 'International seminar on Farmer Suicides,' Pondicherry University, Puducherry, February 10-11.2011).

The intensive agriculture model introduced in India in the 1960s as part of the Green Revolution and the concomitant developments has brought in a package which included massive irrigation projects, new high yielding input responsive varieties and chemical fertilizers. Initially, it did increase production, argues Srijit Mishra (with Gopikishna SR in their 'Nutrient Based Subsidy (NBS) & Support Systems for Ecological Fertilization in Indian Agriculture, Policy Brief, Greenpeace India, 2010). But now, the food production is stagnating and one has been observing diminishing returns and falling dividends, especially in the agriculture intensive areas of the country. Huge amount of subsidy allocation provided directly to the fertiliser industry has led to indiscriminate production and availability while neglecting the locally available knowledge on soil nutrient management.

In "Towards a New Agriculture in Maharashtra," (MEDC Monthly Economic Digest, 39 (5), 34-35,

2010) Srijit Misrha discusses the persistence of the grim scenario in Maharashtra's, particularly Western Vidarbha's agriculture. However, the study concludes by stating that there is an alternative and if the powers that be will, Maharashtra's *ksheti* and *kshetkari* can be taken to greater heights.

Analyzing labor migration from three South Asia countries, namely, Nepal, India and Bhutan, the study by Vijay Laxmi Pandey (with Krishna P. Pant, Dil B Rahut, "Effects of foreign employment on poverty, labour supply and agricultural growth in South Asia: a case study of Nepal, India and Bhutan," SANEI Working Paper Series No. 11-08. South Asia Network of Economic Research Institutes. Dhaka. March 2011) econometrically the effects of foreign employment on poverty and agricultural production especially in the light of recent economic crisis. It also compares agricultural output elasticities of foreign employment and assesses the role of foreign employment on the relationships between growth, poverty and agricultural development. The results from the Nepalese case study show that migration decreases poverty and at the same time decreases agriculture production whereas the Indian case study shows that foreign employment helps in reducing poverty and also promotes agricultural growth. In Bhutan domestic migration is found to decrease poverty. The study has categorized the countries on the basis of the stages of labor migration and has made some suggestions for gaining from the foreign employment. The results will be useful for South Asian countries to devise sound policies on migration, poverty and agricultural development.

Sripad Motiram documents the crisis that Indian agriculture has been going through for several years now (with Vamsi Vakulabharanam "Political Economy of Agrarian Distress in India Since the 1990s," in Sanjay Ruparelia, Sanjay Reddy, John Harriss and Stuart Corbridge (eds.) Understanding India's New Political Economy: A



Great Transformation? London: Routledge, 2011). Looking at both the growth and distribution of the rural sector, the authors argue that the state is failing in its duty to small farmers and other poorer agricultural households in India.

As part of the collaborative project ("Trade, Agricultural Policies and Structural Changes in India's Agrifood System: Implications for National and Global Markets (TAPSIM) sponsored by European Commission) the study conducted by G. Mythili and Nitin Harak attempts at developing a recursive dynamic national computable general equilibrium (CGE) model for India. Based on the static model developed by Ganesh Kumar, the study developed a recursive dynamic blocks to find the impacts of alternative agricultural and trade policies on the output and prices of various sectors and income distributional impacts of households. The static model uses 2006-07 Social Accounting Matrix (SAM) to define the relations. The dynamic model covers the period 2009-10 to 2029-30 with blocks of five years frequency.

# **Energy and Environment**

Presently India is facing the twin challenge of energy universalization as well as emission reduction. As per International Energy Agency estimates India is projected to account for more than 14 per cent share of such emissions 2005-2030, though during India's global incremental energy share is six per cent. The study by Sudhakara Reddy and Hippu Salk Kristle Nathan, (Energy Policy, forth coming) presents a sustainable development scenario by developing a mathematical model, which predicts future demand of different energy carriers by considering various macroeconomic and demographic, supply-side, and demand-side factors. A comparison with business as usual scenario shows a decline in growth rate of fossil fuels and increased share of nuclear and other renewable options, which leads to an average

annual energy saving of 129 MTOE in between 2010 to 2030 and reduction in energy-induced emissions. The paper estimates the infrastructure needs, and discusses investment options, financing mechanisms and the key policy issues.

Sudhakara Reddy attempts at addressing the issue of urban mobility and its impact on energy use and environmental implications by analyzing the transport system in 23 million plus cities in India by systematic comparisons (B.Sudhakara Reddy and P.Balachandra, Transport Policy, forthcoming), This study investigates the quantity of energy use for the period 1981-2005 and present empirical results obtained using national and urban data sets. It explores the underlying relationship among three dependent variables energy intensity, type of mode and passenger km. Patterns of energy consumption and CO2 emissions in private and public transport are examined. Policy recommendations are outlined to reduce urban transport energy use and greenhouse gases and provide suggestions to achieve sustainable urban mobility. The results are intended to assist the assessment of future road transportation demand and mobile-source emissions, in which the technical capabilities and data availability may vary considerably.

In another study, "Energy efficiency in cement industries," Sudhakara Reddy [with Binay Kumar Ray and Balachandra, Energy Economics (submitted)] finds that significant variations exist in energy intensity across cement firms over time in India. These variations indicate the opportunities for increase in energy efficiency through the incorporation of efficient technologies, optimal use of raw material mix, management practices and optimization of processes. Modeling the variation of energy intensities across firms over time with the help of panel data this paper investigates the factors that affect intensity. The results show that energy intensity is correlated positively to clinker production and negatively to slag use.



How does product differentiation as well as strategic managerial delegation affect optimal emission tax rate, environmental damage and social welfare, under alternative modes of product market competition? This has been examined by Rupayan Pal ("Delegation and Emission Tax in a Differentiated Oligopoly" The Manchester School, forthcoming, 2010, Wiley-Blackwell). The study shows that under pure profit maximization, the optimal emission tax rate is not necessarily decreasing in degree of product differentiation, irrespective of the mode of competition. It also shows that, under price (quantity) competition, the equilibrium emission tax rate, environmental damage and social welfare are lower (higher) in case of delegation than that in case of no delegation. In another study, Rupayan Pal ( with R. N. Bhattacharya, "Environmental Standards as Strategic Outcomes: A Simple Model," Resource and Energy Economics, Vol. 32, No. 3, pp. 408-420,2010, Elsevier) analyzes the strategic nature of choice of environmental standards considering both local and global pollution under alternative regimes of international trade. The study shows that, in case of open economies, environmental standards can be either strategic substitutes or strategic complements. On the contrary, in case of closed economies, environmental standards are always strategic substitutes. It also shows that the strategic equilibrium environmental standards in case of open economies are higher than the world optimum in certain situations. In the absence of international trade, countries set, in equilibrium, lower environmental standards than the world optimum.

Considering a differentiated products mixed duopoly, Rupayan Pal (with Bibhas Saha "Does partial privatization improve the environment?," IGIDR-WP-2010-018) demonstrates that environmental damage is non-monotone in level of privatization. It shows that, though partial privatization is socially optimal, social welfare maximizing level of privatization may damage

the environment most. It also shows that, if the government ignores environmental damage due to production, the equilibrium level of privatization would be lower than socially optimal level of privatization.

Rupayan Pal (with Bibhas Saha "Mixed Duopoly and Environment", IGIDR-WP-2011-005, 2011) shows that under general demand and cost conditions in a mixed duopoly with pollution the government can (and will) implement the socially optimal outputs and abatements by a tax-subsidy scheme and keeping the public firm fully public. The scheme requires taxing outputs and subsidizing abatements at different rates, unlike a pollution tax. The result contradicts some of the recent claims that social optimum is not implementable and privatization is necessary.

Urban transportation is growing as one of the major GHG contributors in the world. An alarming fact is that the growth of this sector is much rapid in Asian Cities and under business as usual scenario, this sector has the potential to contribute to Climate Change significantly. an interesting study, Sudhakar Yedla, ("Climate Change Mitigation Initiatives in Urban Transportation - Strategies to Promote Non-Motorized Modes of Transportation," evaluates Climate Change and Development, Published by Global Environment Facility (GEF) Evaluation Office, The World Bank, Washington, D.C., 2010) identifies certain barriers for the promotion of Non-Motorized Modes of Transportation (NMT) in Mumbai, by means of multi-stakeholder participation. Through multi-stakeholder participation and multi-criteria analysis, the study further develops various policy measures to promote NMT and prioritize them. Through careful examination of various policy alternatives, their ranking, characteristics of Mumbai transport system, experiences from the other similar cities, and social conditions of Mumbai, the present study recommends a set of short and long term measures to promote NMT in Mumbai.



Dhaka's community-based decentralized (DCDC) composting is successful а demonstration of solid waste management by adopting low-cost technology, local resources community participation and partnerships among the various actors involved. In this context. Sudhakar Yedla attempts to understand the model, necessary conditions, strategies and their priorities to replicate DCDC in the other developing cities of Asia. ("Decision Making in Environmental Management - Prioritization of Strategies for the Replication of Dhaka's Community-based Decentralized Composting Model using AHP", Waste Management Research, first published on August 10, 2010 doi:10,1177/0734242x10380116). Thirteen strategies required for its replication are identified and assessed based on various criteria, namely transferability. longevity, economic viability, adaptation and also overall replication. Based on the analysis, measures to ensure the product quality control; partnership among stakeholders (public-private-community); strategies achieve better involvement of the private sector in solid waste management (entrepreneurship in approach); simple and low-cost technology; and strategies to provide an effective interface among the complementing sectors are identified as important strategies for its replication.

Prioritizing the alternative options for energy efficient and less polluting transport system in Delhi, the paper by Sudhakar Yedla [with Ram M. Shrestha, "Application of Analytic Hierarchy Process to the Prioritization of Transport Options - Comparative Analysis of Group Aggregation Methods" International Journal of Environmental Policy Decision making, Inderscience and Publishers, (in press)] presents a comparative analysis of different group aggregation methods adopted in analytic hierarchy process by testing them against social choice axioms with a case study of Delhi transport system. It has been observed that among all group aggregation

methods, geometric mean method, the most adopted group aggregation of analytic hierarchy process, shows poor performance and fails to satisfy the most popular 'Pareto optimality and non-dictatorship axiom' raising questions on its validity as group aggregation method. Further, the weighted arithmetic mean methods with equal weights aggregates individual priorities better compared to arithmetic mean method with varying weights. Arithmetic mean of the priorities by individual members of the group shows minimum deviation from the group consensus making it most suitable and simple methods of aggregation.

In another study, Sudhakar Yedla (with Krishna Chaitanya T., "Adsorption of Hexa-valent Chromium Using Treated Wood Charcoal Elucidation of Rate-limiting Process". Environmental Technology, UK, Vol. 31 No (14) pp:1495-1505, 2010) focuses on development of low cost methods of water treatment for rural application. Locally available wood charcoal used as an adsorbent to remove Cr (VI) from water is found to be giving poor removal efficiency whereby only 19 per cent of Cr (VI) has been removed. Considering the fact that wood charcoal possesses a honeycomb structure, treatment with concentrated hydrochloric acid has improved the removal efficiency of wood charcoal to 94 per cent. The process limiting the rate of adsorption (rate limiting step) is analyzed using the kinetic data as well as using various systemic parameters such as initial Cr (VI) concentration, adsorbent size, and agitation speed is finally confirmed by the multiple interruption tests. It is concluded that the adsorption process is controlled by film diffusion and the removal capacity is good enough to make it economically viable method of water treatment.

Vinod K. Sharma, as an expert work group (WG) member for an elaborate research conducted in several countries by the AIST, Japan and the ERIA, Indonesia, supervises and suggests



investigations on various aspects of "Sustainable Biomass Utilization in East Asia," including India. The WG highlights various crucial issues and suggests some necessary steps, which could be useful for achieving sustainable biomass utilization in the production and consumption of bioenergy in the EA region. The WG gives policy recommendations for the Energy Ministers' of the EA countries including India.

The hypothesis underlying the Environmental Kuznets curve (EKC) that the environmental pressure tends to rise faster than income growth in the early stages of economic development, and then declines with further economic growth, has been tested empirically by G. Mythili and Shibashis Mukherjee ("Examining Environmental Kuznets Curve for River Effluents in India", Environment, Development and Sustainability: Springer, Volume 13, No. 3, 2011) with reference to river effluents using the data for India from 1990-91 to 2005-06. This study shows why the conventional EKC model is not sufficient to ascertain the declining path of pollution as the economy grows in the second stage. The results indicate 'tilted-S shaped' relationship which contradicts EKC in the early stages. Most of the regions studied have crossed the first turning point but are still to cross the second turning point which means that there will be an ascent in the pollution level in the future. This calls for more stringent environment policies complementing the desired growth path.

# **Industrial Organization**

The paper by Rupayan Pal ("Technology Adoption in a Differentiated Duopoly: Cournot versus Bertrand," Research in Economics, forthcoming in Vol. 64, No. 2, pp. 128-136, Elsevier, 2010) shows that the cost as well as the effectiveness of technology has a differential impact on technology adoption under two alternative modes of competition. If the cost of the technology is high, Bertrand competition

provides а stronger incentive to adopt technology than Cournot competition unless the effectiveness of the technology is very low. On the contrary, if the cost of the technology is low, Cournot competition fares better than Bertrand competition in terms of technology adoption by firms. This demonstrates that the commonly subscribed assumption of 'positive primary outputs' restricts (inflates) the scope of higher degree of technology adoption under Bertrand (Cournot) competition. Moreover, in contrast to standard welfare ranking, it shows that Cournot competition leads to higher social welfare than Bertrand competition under certain situations.

By investigating the impact of group incentives on firms' performance, the study by Rupayan pal (with Kshitija Dixit, "The Impact of Group Incentives on Performance of Small Firms: Hausman-Taylor Estimates," Managerial and Decision Economics, Vol 31, No. 6, pp. 403-414, Wiley-Blackwell, 2010) shows that group incentive raises firms' performance. This result empirically validates the implication of the theoretical literature that performance-related pay can potentially improve firms' performance, in the context of a developing country, and indicates the importance of group incentives in small firms. It also shows that partnership firms perform better than private limited companies and labor unions have a negative impact on firms' performance. It employs the Hausman-Taylor random effects estimator in order to isolate the effects of timeinvariant covariates and also to tackle potential endogeneity problem.

In another paper, Rupayan Pal ("How Much Should You Own? Cross-Ownership and Privatization." IGIDR-WP-2010-015. 2010). interdependence of examines the crossownership and level of privatization in case of differentiated products mixed duopoly. The paper shows that it is optimal for the private firm not to own any (own the entire) portion of the privatized share of its rival firm, if the level of privatization



is very low (very high). In equilibrium, the government makes sure that cross-ownership is not attracted. However, in most of the situations, the possibility of cross-ownership adversely affects the prospect of privatization. Results of this paper have strong implications to antitrust regulations and divestment policies.

#### **Finance**

Susan Thomas (with Nidhi Aggarwal, "Liquidity matters in price discovery") studies the price discovery process between the single stock futures and the underlying markets in India, and finds that price discovery takes place in the most liquid market, independent of the presence of leverage. Thus, when the derivative market is also the more liquid market, the derivative market drives price discovery; whereas, if the underlying market is more liquid, then it dominates price discovery. This research highlights the importance of liquidity in price discovery, and emphasizes that development of markets must focus on making design choices which enhances liquidity of the market. In another paper, Susan Thomas (with Rohini Grover, "Liquidity considerations in estimating implied volatility") proposes alternative schemes to estimate implied volatility while reducing the importance attached to illiquid options. Using data for index options traded at the National Stock Exchange in India, it has been found that the performance of a liquidity weighted scheme is superior to that of more conventional schemes such as the vega weights, the volatility elasticity weights and the traditional VXO. Analyzing the impact of short sales constraints on securities market liquidity, Susan Thomas (with Rajat Tayal) develops a measure of liquidity which captures how the liquidity varies across different transaction sizes and different times of the day for all traded securities. It has been found that the liquidity of the market worsens exponentially as the trade size increases. Further, the drop off of liquidity is worse on the buy-side of the market, compared

to the sell-side. This suggests that large sized sales tend to be done at a higher premium compared to smaller sized buys.

Susan Thomas (with Ekta Selarka: "An index to measure securities market liquidity") poses two questions: Does pre-trade liquidity (measured by the impact cost in the limit order book) predict post-trade liquidity perfectly? Can changes in pre-trade liquidity, which can be observed by all traders in the electronic LOB markets in India, predict changes in post-trade liquidity? How can we combine these different measures of liquidity into an index that measures liquidity at the level of the security as well as the level of the market. In the study, alternative "index" candidates are compared by examining their sensitivity to changes in the market which are exogenously identified as periods of known changes in liquidity. The paper "Methods for more capital efficient margining at the securities market clearing corporations," by Susan Thomas (with Renuka Sane and Manish Singh) attempts to examine if correlations between stocks can be used to design more capital efficient margins which do not compromise on protection. The paper finds that gross margins are about 1.5 times the portfolio margins on an average. The portfolio-based margining system does well in stable periods. However, in times of crisis such as the financial crisis of 2008, it is not able to provide protection, while the gross-based margin does. The paper thus sets the framework for studying more robust models that can perform well even in crisis periods, such as multivariate GARCH and Copula methods.

During the Global Financial Crisis, the global Over-The-Counter markets were severely criticized for not having the liquidity to support credible prices for the securities they traded. The exchange traded markets, on the other hand, were held up as far better market mechanisms for price discovery and liquidity access. However, this complacence vanished with the Flash Crash



of 6th May, when the market underwent a liquidity crisis resulting in extreme price drop, and then a full correction, all within a very short period of time. The political system and the regulatory system then brought the same intense scrutiny to the participants and the processes on the exchange traded platform, making significant changes to the market microstructure. In the paper on "What can we learn about the U. S. Flash Crash of 6th May, 2010?" Susan Thomas (with J. R. Varma) examines the possibility of a similar situation of a liquidity crisis taking place in the Indian equities market, and what the regulatory response ought to be. The paper concludes that while the equity market structure in India is far less fragmented compared to the U.S. Markets, there is a need to continually improve the transparency and the access to the markets, to ensure a higher probability of continuous liquidity.

# **Corporate Governance**

A striking characteristic of business groups in emerging economies is their diversification across disparate industries despite the well known costs of diversification. Based on a study of diversified business groups in India, Jayati Sarkar (with Raja Kali, "Diversification and Tunneling: Evidence from Indian Business Groups" Journal of Comparative Economics, forthcoming) provides evidence suggesting an important, yet largely unexplored motive for the diversified structure of emerging economy business groups is to facilitate expropriation of minority shareholders by controlling shareholders through tunneling. To establish the link between diversification and tunneling, the study conducts two sets of empirical analyses on a sample of 2128 Indian group-affiliated firms for four consecutive years, 2002 to 2006. Defining the core firm of a group as the one with the largest asset base in the group, the study finds that after controlling for other important motives for diversification, the relatedness of the activity of a group affiliate to

the activity of the core firm is correlated to the wedge between control and cash flow rights of insiders as well as to the opacity in insider ownership. Firms with ownership-control wedge lower, and ownership opacity higher relative to a group's core firm are found to be more likely to be in activities unrelated to that of the core firm. The findings are strengthened by the evidence of tunneling that we find in the same direction, from affiliates with wedge equal to or higher than that of the core firm to affiliates with wedge lower than that of the core firm. Taken together, this suggests an expropriation motive for diversification in Indian business groups: affiliate firms are located away from a business group's core firm to serve as destination points for funds tunneled from the group's core.

In the study "Abstract of Business Groups in India, Jayati Sarkar (Business groups in India. In: Colpan, Asli M., Hikino, Takashi, Lincoln, James R. (Eds.), The Oxford Handbook of Business Groups. Oxford University Press, 2010) examines the evolution of family business groups in India. It focuses on the dynamics underlying the persistence and resilience of Indian groups as a dominant organizational form, notwithstanding significant changes in the institutional environment, starting from the colonial years under British rule to the post-independence years of private sector regulation, and finally to the increasingly liberalized environment since the nineties. In this context. the study analyzes the organizational structure, diversification strategies, competitive capabilities, and governance and performance of Indian groups. The basic conclusion is that the evolution of Indian groups has elements of both continuity and change. The continuity, despite periodic structural shifts in the policy and institutional environment, has been preserved in terms of group dominance in corporate sector activity, in the spirit of entrepreneurship, the persistence of concentrated ownership and control, the extent of managerial integration, and in the extent of group diversification. Elements of change in the evolution



are apparent from the turnover among groups in terms of their relative importance in the group hierarchy, indicating considerable heterogeneity in group responses to a dynamic environment.

### **Labor Economics**

Rupayan Pal ("Impact of Communist Parties on the Individual Decision to Join Trade Union: Evidence from India," The Developing Economies, Vol. 48, No. 4, pp. 496-528, Wiley-Blackwell, 2010) analyzes the impact on individual decisions to unionize of several factors: the reach of communist parties, the degree of political activism, personal attributes of workers, and industrial characteristics. The workers examined are Indian nonagricultural regular workers, using micro-data from the 2004–5 Employment and Unemployment Survey conducted by the National Sample Survey Organization, linked to state-level factors. A notable result is that the reach of Communist parties has considerable effect on unionization probability. Moreover, it seems that the mere existence of communist parties in a state also facilitates unionization to some extent. Statelevel political activism and unemployment rate also influence the individual decision to join a union. The paper also concludes that a worker's gender, marital status, ethnic background, employment status, experience, occupation, sector of employment, establishment size, and type of industry remain important in the determination of union membership. In another paper, Rupayan Pal (with Bibhas Saha "Entry Threats and Inefficiency in 'Efficient Bargaining," IGIDR-WP-2010-016,2010) examines whether the outcome of bargaining over wage and employment between an incumbent firm and a union remains efficient under entry threat. The workers' reservation wage is not known to the entrant, and entry is profitable only against the high reservation wage. The entrant observes the pre-entry price, but not necessarily the wage agreements. When wage is not observed,

contracts feature over-employment. Under separating equilibrium the low type is over-employed, and under pooling equilibrium the high type is over-employed. But when wage is observed, pooling equilibrium may not always exist, and separating equilibrium does not involve any inefficiency.

#### **International Trade**

C. Veeramani (with Gordhan Kumar Saini, "Impact of ASEAN-India Preferential Trade Agreement on Plantation Commodities: Simulation Analysis" Economic and Political Weekly, Vol XLVI, No. 10, March 5, 2011) analyses the impact of recently signed ASEAN-India preferential trade agreement (AIPTA) on plantation commodities - coffee, tea and pepper. The likely increase of imports into India has been simulated using the SMART model (developed jointly by UNCTAD and World Bank) and gravity model. The analysis shows that the agreement may cause a significant increase in India's imports of plantation commodities from the ASEAN countries. The increase in imports is mostly driven by trade creation rather than trade diversion. Trade creation improves welfare as the new imports replace the high-cost domestic The proposed tariff reduction production. may lead to some loss of tariff revenue to the government. However, the gains in consumer surplus (due to the fall in domestic price and the consequent reduction in dead-weight loss) outweigh the loss in tariff revenue leading to net welfare gain. During the years to come, the plantation sector will have to realign the production structure according to the changing price signals. It is important to devise appropriate adjustment assistance schemes for planters as well as for plantation workers who might be displaced.

Trade liberalization is expected to bring about an improvement in the sophistication level of a country's export basket. Using highly



disaggregated trade data, C. Veeramani (with Gordhan K Saini "India's Export Sophistication in a Comparative Perspective, " in D M Nachane (ed.) India Development Report 2010, Oxford University Press. New Delhi (forthcoming) attempts to analyze the relative sophistication of India's exports of manufactures during pre and post-liberalization periods. the Export sophistication is analyzed in terms of two different dimensions - across product sophistication and within product sophistication. The analysis confirms a growing similarity of India's export bundle with that of the highincome OECD. While China shows a higher level of sophistication than India in the across product dimension, India ranks above China with respect to sophistication in the within product dimension. It is evident that India's export unit values are distinctly higher than those of China. It has been argued that India's higher export unit values compared to those of China is a reflection of distortionary policies in India that encourage specialization in capital and skill intensive varieties/process at the cost of unskilled labor intensive activities where the country holds its true comparative advantage.

## **Placement Cell**

IGIDR has a full fledged on-campus placement program. The placement process is being coordinated by the Dean, Students Welfare, who is supported by the faculty and student members of the placement committee. The placement committee provides a platform for students seeking recruitments to interact with possible recruiters on campus. The placement committee cordially invites corporate firms, banks, research organizations, government institutions and non-government institutions to be a part of the placement process at IGIDR. Many reputed companies have been visiting the campus to recruit students to meet the increasing demand for their research, business intelligence and analytics support groups. ## **Library and Information Services**



The IGIDR library is rapidly building up to be one of the leading professional research and reference libraries in the country. All bibliographic details of books, journals and CD-ROM databases are accessible through the campus-wide Ethernet network. The library has over **91,500** printed documents and it subscribes to over **460** national and international journals.

It has established contacts with over 100 national and international organizations for exchange of the Institute's publications and inter-library loan arrangement. The institute library also has an account with BLDS under GDNET program to meet its inter-library loan requirements.



## **Library and Information Services**

The library homepage provides links to various websites, which are of importance to economists. Access to electronic journals, union catalogue of periodicals, library catalogue, journal holdings, current journals, etc have also been provided from this homepage. The recent inclusion on 'Indian Economy' provides links to various internet resources related to Indian Economy.

IGIDR library has developed an online **Union catalogue** of journal holdings, the data for which comes from 18 major Business and Economics libraries of the country. The catalogue has provided a platform for sharing resources among libraries. Library under its online portal '**Open Index Initiative**' has developed a searchable database for index to articles published in Indian social science journals. The database contains about 75,000 records covering data of 10 years. (2000-2010)

The library has given due consideration to the most modern approach in the field of librarianship. The **Electronic Library** is about to bloom with an initial collection of 3000 documents and is accessible through the campus network. The Electronic library aims to collect articles, discussion/working papers, books, etc, which are available in public domain. It also intends to have in its collection the entire thesis submitted to the institute by M.Phil and PhD students. The library has developed the Institutional Repository '**Kautilya**' using open source software DSpace. This repository contains full text of the institute's working papers, abstract of theses submitted to IGIDR, proceedings of conferences organized at and by IGIDR.

# **Computer Facilities**

The computer facilities at IGIDR include a state-of-the-art technology Computer Center (CC) with latest hardware, networking equipment, software and help desk facilities. The whole office campus is networked by Ethernet-based LAN on fiber optic segmented backbone and connected to Internet through 7 MBPS leased line. Important campus locations are also served by wireless network. In addition, the computing facility includes a computerized library system. The campus network has been extended to the residences of the employees.

#### **Hardware**

The CC is equipped with high-end HP ITANIUM servers, HP NAS server, AMD OPETRON server and Intel Pentium based multimedia workstations, CISCO switches and routers for campus wide network connectivity. In addition to several HP Deskjet printers in the faculty and staff offices, the printing facilities also include high-speed Network HP Laser printers, in each office block including the CC. The CC also provides total backup solution for users data through various backup devices viz., DAT, CD/DVD writer, and LTO-2 tape drive, color scanners, visualizers and projectors have been provided to assist the users in creating and presenting multimedia presentations.

## **Operating Systems and Software**

The servers are powered LINUX, Windows Server Operating systems and the workstations are loaded with Linux (viz.,Ubuntu, Suse, Fedora,), Windows 7 / XP/ OS. The CC provides all standard Econometrics and Statistical packages such as SAS, RATS, CATS, GAUSS, STATA, LIMDEP, MATHEMATICA, MATLAB and GAMS,EVIEWS, MAPINFO under Unix/Linux and windows environments and office automation packages like OPEN OFFICE, MSOFFICE, LATEX,ADOBE ACROBAT under Unix/Linux and Windows environments.

In addition to the above software, the institute subscribes to corporate databases such as PROWESS, CAPITAL LINE, INDIASTAT.COM and various other national and international databases.




